PART 9: THE ROAD TO JERUSALEM

THE SCATTERING OF ISRAEL

There are few constants in this world. God's word is one of them. When He makes a promise, it cannot be broken. This is precisely what happened when God spoke through Moses and warned the people that they would be scattered all over the world if they did not obey His commandments. **Deuteronomy 28:63-68**

God brought back a remnant from Babylon some 500 years before Christ and gave them a chance to turn from their rebellion. **Ezra 2:1, 64**

But when Jesus arrived and they rejected Him as the Messiah, God rejected them and the curse spoken through Moses came into full force and the remnant was scattered into many nations. **Matthew 27:22-25**

Rabbi Solomon Grayzel made the following statement:

“The Miracle of Jewish Survival – Nevertheless we can speak of the history of the Jewish people. For, although the Jews were no longer a nation, in the usual sense of a territorial group, they still continued to feel united. That is one of the outstanding marvels in all human history. When Assyria was destroyed, there ceased to be any Assyrians; when Egypt was conquered, there were no longer any Egyptians, except in so far as the people who live in that land are still called by that name. The Jews, however, still survive, although Judea was conquered and the Jewish nation destroyed, almost nineteen hundred years ago. The reason for this most unusual situation is that the Jewish Idea, or Judaism, was made more important than the Jewish land and Jewish national life.”¹

There is no doubt that the survival of the Jews is supernatural because God promised to keep a remnant who will be given a chance to receive salvation at the end before Jesus comes back the second time. **Isaiah 10:20-23; Romans 11:25-27**

Satan has his own plans for the Jewish people and he is using supernatural power to further his agenda. He had infiltrated the synagogue system that has replaced the temple in Jerusalem, and through this system, he has been able to perpetuate the Kabbalistic doctrine for the last 1,900 years. **Revelation 2:9; 3:9**

Satan made sure that the synagogue system was protected as he unleashed war and destruction for the past 1900 years. Furthermore, he instigated the conversion of the king in the Khazar Empire (720-1050), which resulted that the majority of the people in

Khazaria converting to Judaism. The king invited Jewish rabbis to settle in Khazaria to build synagogues and educate the people in the doctrine of Judaism.

The Khazar people came from Turkish and Iranian tribes and were not blood descendants of Abraham. When the Khazarian Empire was invaded and destroyed at the end of the 11th century, its people had become practicing Jews and they were called the 13th tribe.² Millions of Khazar Jews were forced to flee and ended up in Russia and Eastern Europe. Thus, most Jews in Russia and Eastern Europe are in reality Khazars and not covered by God's covenant with the children of Israel. The Zionist movement in the 19th century was largely led and controlled by Khazar Jews.

TUMULTUOUS CENTURIES

The current exodus of Muslim refugees from the Middle East into Europe cannot be compared to the movement of people during the time from the second century to around 1300. The Vandals were a Germanic tribe living in Sweden who decided to invade central Europe and millions of people were pushed out of their way and had to settle in other parts of Europe. There were other Germanic tribes from Sweden like the Goth and the Lombards, who also pushed their way through Europe and forced millions to become refugees and resettle in other places.

In the fourth century, a nomadic people from Mongolia called the Huns invaded eastern Europe, conquering nations and millions of people were forced to flee and settle in different parts of Western Europe.³

During the years 1206-1227, there was the Mongolian invasion under the leadership of Genghis Khan, who created such a terror that millions of people became refugees again and settled in Western Europe.

During this thousand year period of instability and mass migration of people groups, the Jews maintained their enclaves in the different areas of Europe and a large group was clustered in what is today Iran and Iraq.

JEWISH CONTROL

Jews can only flourish financially in nations under stable governments and it was not until the 14th century after the threat from Mongolia had been eliminated that nations began to form in Europe. Germany was split into different city states, but Holland, France, Spain and England were able to establish stable governments. The result was a development of commerce, manufacturing and banking systems. Italy existed under the stable influence of the Roman Catholic Church and its popes.

Jewish people had a common language because they maintained their Hebrew while being fluent in the language of the nation in which they lived. They settled in and became masters in banking and commerce.

It is clear in reading the 13th chapter of the Book of Revelation that the Antichrist system is not built upon military power but strict financial control. **Revelation 13:16-18**

When we examine the actions of Lucifer, we can see how he thinks and plans. Since the time of Noah's flood, the Devil has created empires such as Babylon, Persia, Greece, Rome, etc., but none of them was ever to create a world government capable of controlling the world through military might. True world control can only come about through economic means.

THE FUGGER FAMILY

Satan is only interested in one piece of real estate and that is the land of Canaan. He is determined to have his ungodly people possess this land and set up a government in the city of Jerusalem. The Kabbalistic leadership is working to make this desire of Satan a reality and therefore the Jewish Kabbalistic leadership has no interest in making just any nation into a Jewish homeland; they have only one goal and that is Jerusalem and the land of Canaan.

The Kabbalistic leadership picked a German by the name of Hans Fugger to do their bidding. He was financed by the Kabbalistic leadership and started his enterprise in the city of Augsburg, Germany in 1367. Using the provided money, he was able to take control of the weaving business in Augsburg. Hans Fugger had two sons, Andreas and Jacob, who didn't work in the textile business, but were trained as goldsmiths.

At the death of their father in 1408, Andreas and Jacob took joint control of the family business. The two brothers divided the business in 1454 and Andreas became very wealthy but overextended himself and went bankrupt.

Jacob Fugger died in 1469 and left behind great wealth. Only two of his seven sons carried on the Fugger business enterprise. Ulrich and George extended their business into other nations and became involved in banking and selling financial commodities. They were granted nobility in 1473 and the corresponding coat of arms had a lily on it. The new family name was "Fugger von der Lillie."

Their brother Marcus had relocated to Rome and was able to exert great influence with the Vatican. The Fugger family enterprise was given the exclusive right to handle all financial transactions from the sale of indulgences for the papal court in Rome. The Roman Catholic Church had to pay the Fugger's a hefty fee for supervising the priests, collecting the money and sending what was left to Rome.

The Fugger family leased the Roman Mint from 1508-1515 and were in complete control of the finances of the Roman Catholic Church during that time period.

The youngest brother, Jacob II, was brought into the family enterprise in 1487. He was stationed in Innsbruck, Austria and expanded the family business into mining. In time the Fugger's dominated the mining industry in Central Europe with a monopoly on mining and refining copper.

The Fugger family financed Charles V, who became the Emperor of the Holy Roman Empire and also the King of Spain. Jacob Fugger II contributed 544,000 gold guilders to help Charles V secure his titles to the different national thrones. This was an enormous sum of money, equivalent to 82 million dollars today, but to the Fugger family it was like small change. As a result of his enormous wealth, Jacob II became known as Jacob the Rich. Jacob II did not provide all that money to Charles V because he liked him; it was

an investment that Charles V had to pay back that would be worth far more than Jacob II had invested.

There were three knightly orders which leased properties from the Spanish crown. In order for Charles V to pay back his debt to the Fugger's, he relinquished these lease payments and turned them to Jacob II. Charles V also turned over the money which came from the mercury mines in Almaden and silver mines in Guadacanal.

Jacob II became so rich that he reached out to England with huge loans to King Henry VIII and he too became indebted to the Fugger family. Jacob II died in 1552 and the Fugger family enterprise was turned over to his nephew, Anton Fugger. Using the wealth of the Fugger family, King Charles V was given enormous loans which made him obligated to grant permission to all kinds of money making schemes. When gold and silver began to arrive from South America, most of it ended up in the coffers of the Fugger family. Later King Ferdinand I and King Phillip II of Spain were so heavily in debt that they granted the Fugger family the mining rights in Chile and Peru to pay off the obligation.

The practice of kidnapping black people in Africa and selling them as slaves to land owners in North America was a lucrative business for the Fugger family. In 1546 Anton Fugger had amassed a fortune of 5.1 million gold guilders. That would be the equivalent of 765 million dollars today.

Anton Fugger had five sons when he died but they were not able to handle the family business and in a few years the once mighty Fugger empire dissolved and their grip on political leaders came to an end.

The Kabbalistic leaders learned a harsh lesson with the Fugger family. In the future they would only use Kabbalistic Jews, and when one generation passed, the wealth would only go to the eldest son in order for it not to be lost.

THE REAPPEARANCE OF THE KABBALAH

Around 1250 in Spain, a Jewish rabbi and scholar on the Kabbalah by the name of Moses ben Shem-Tov de Leon, announced to the Jewish community that he had found a commentary on the Pentateuch (Five Books of Moses), which had been written by Rabbi Simon bar Yochai sometime after the last Jewish rebellion against Rome from 132-135 A.D.

According to Jewish tradition, Rabbi Simon lived in a cave for 12 years to hide from the Roman government. Angels came and instructed him to the true meaning of the five books of Moses and he wrote down the revelations given to him.

Rabbi Moses ben Shem-Tov published the book under the name "Zohar," which means brilliance.

In 1492 the government of Spain expelled all Jews, and Spanish and Portuguese Jews settled in Jerusalem and Safed, a village at the Sea of Galilee. The Jews that settled in Safed were Kabbalists and a conflict broke out between the two Jewish groups concerning who would be in charge of Jewish matter in Palestine. Rabbi Jacob Habib was the head of the Kabbalistic scholars in Safed, which became the center of Jewish Kabbalism. Safed is still in 2015 a Kabbalistic center.

Rabbi Isaac ben Solomon Luria (1534-1572) had dedicated his life to the Kabbalah and the Zohar. He taught re-incarnation, claimed that he was the messiah and that he was the son of Joseph, the son of the patriarch Jacob. Luria did not write much but his doctrine was written down by his disciples.

At this time in history, three Jewish centers had come into being, each vying for the power to control the Jews of the world.

1. Amsterdam, Holland - Jews from Spain and Germany had settled there.
2. Poland - Mainly Khazar Jews had formed a Jewish council in 1530.
3. Palestine - Where the group from Safed quarreled with the Jews of Jerusalem.

Satan took the teachings of Rabbi Luria and spread them throughout the Jewish Diaspora, and by 1632, Lurian Kabbalism had influenced the spiritual life of Jews, including their literature and religious rituals. Mixed with the Kabbalah was the teaching of the Talmud, which taught that Gentiles had no value, a child under the age of three could be sexually molested with no consequences, and that it was legal for Jews to lie and cheat Gentiles out of property. The Kabbalists went even further and lived as sinful as possible in order to serve God.

Ukrainian Cossacks revolted against the Polish government in 1648, and since Jews held government positions, the wrath was taken out on the general Jewish population in Poland, which more or less destroyed any hope of Polish Jews taking control of the Jews in the world.

SABBATAI SEVI

As the year 1666 was approaching, the Kabbalistic leadership in Safed decided the time had come to take over the world. The man that Satan selected to be his messiah was Rabbi Sabbatai Sevi (1626-1676) and Rabbi Abraham Nathan of Gaza (1643-1680) was to be his prophet.⁴

Sabbatai began preaching that he was the messiah and Nathan backed up his claims with supernatural power. Satan is not powerless and he empowered these two men to heal the sick, and when they laid hands on people, they lost control and fell to the ground. Letters were sent to the different Jewish settlements in Europe, Babylon and North Africa and the majority of the Jews accepted Sabbatai as their messiah. Sabbatai and a group of his followers traveled to Constantinople in 1666 to confront the sultan, the ruler over the Ottoman Empire and demand that he would surrender to Sabbatai.

Instead of surrendering, the sultan had Sabbatai arrested and after some time he was given the ultimatum of converting to Islam or being executed. Sabbatai chose to convert to Islam and was set free. This caused a shockwave among the Jews that had accepted Sabbatai as the messiah, but then Nathan declared that Sabbatai had committed the worst sin possible in order to pay for the sins of all Jews.

According to the Kabbalah, Sabbatai had served God by sinning. Nathan urged all followers of Sabbatai to enter the abyss with him and convert to the religion of the land in which they lived. They were to secretly remain Kabbalistic Jews and renounce the

pagan religions they had converted to on their death beds. Millions of Jews did so and they became known as “crypto Jews.”

Some of the most famous crypto Jews were the British Prime Minister Benjamin Disraeli (1804-1881) and Karl Marx (1818-1883), the founder of Communism.

FRANKFURT AM MAINE, GERMANY

As the Ottoman government clamped down on the Jewish Kabbalists in Palestine, the Kabbalistic leadership realized the attempt to take over the Ottoman Empire with the help of Sabbatai Sevi had failed. Even though Sabbatai and Nathan had displayed supernatural power, it was not enough to vanquish the sultan.

With the failed attempt, the Kabbalists knew they had to gain financial control over the world and rule the nations with a puppet government. Three Jewish Kabbalistic men were selected for this task.

1. Jacob Frank (1726-1791) was to fine tune the doctrine of the Kabbalah to be introduced to the Jewish people
2. Meyer Amschel (1744-1812) was to create a financial empire that would enslave all nations.
3. Adam Weishaupt (1748-1830) was to create a secret political society (Illuminati) to control political leaders.

All three men were successful and the fruit of their labor was war, unemployment and the destruction of morality in mankind.⁵

THE ZIONIST MOVEMENT

The Kabbalistic leadership knew that taking control of Palestine and Jerusalem would be a long term endeavor. The followers of Jacob Frank (Frankists) radicalized young Jewish people while the Rothschild banking dynasty took control of finances in Europe and the United States and the Illuminati infiltrated every Masonic lodge in the world. The Kabbalists needed to create a movement of people that could seize control of Palestine. This project was given to a Hungarian Jew named Theodor Herzl ((1860-1904).

Herzl published the book “Der Judenstaat” (The Jewish State) in 1896 which was a blueprint for taking control of Palestine and establishing a political Jewish state. In 1898 the first World Zionist Congress was held in Basel, Switzerland and they drafted a plan to establish a Jewish state and gain political and financial control of the world.⁶

One thing was clear to the Kabbalistic leadership, the Ottoman Empire had to be destroyed in order to set Palestine free and this was accomplished through the First World War. At the signing of the Versailles treaty on June 28, 1919, the Ottoman Empire was divided and Turkey came into existence. There was a large Jewish delegation present which had been approved by the governments of France, England and the United States. The name of the committee was “Committee of Jewish

Delegations to the Peace Conference” and was the forerunner to the Jewish World Congress.

BRITISH PALESTINE

England was delegated at the peace conference with the responsibility of holding Palestine as a mandate for the League of Nations, the forerunner to the United Nations. Using the Balfour Declaration as a political weapon, the Zionist World Federation demanded that Jews be allowed to settle in Palestine. A quota was set up and from 1919 until 1945, Jews were allowed to immigrate and settle in Palestine. Since the immigrating Jews were small in number comparing to the Palestinian population, there was harmony and Jews were able to purchase land and houses from the local population.

Eventually the secret Jewish leadership in Palestine developed two military groups called the “Hagana” and the “Stern Gang.” They were freedom fighters in the eyes of the Jews but were considered terrorists by the British military government.

When the Second World War broke out in 1939, the Jews in Palestine offered to form military units attached to the British Army. Since Turkey was allied with Nazi Germany, the British government accepted the idea and thus the Jews had their first army units which were trained and equipped by the British Army.

At the end of the war, the Jewish leadership in Palestine declared war on England and demanded that millions of Jews from Europe be allowed to immigrate to Palestine. The British government resisted and so the Hagana and the Stern Gang began guerrilla warfare. The King David Hotel in Jerusalem was blown up and scores of British soldiers and officers were ambushed by the “freedom fighters/terrorists” and in turn the British executed the Jewish fighters.

The United Nations sent the Swedish Count Bernadotte to Palestine to try and arrange a peaceful solution to the tension, but he barely set foot on the ground when he was murdered by members of the Stern Gang.

Eventually the losses were so heavy for the British government that the people in England simply wanted out of Palestine and the British began to relax its resistance to the Jews.

The Kabbalistic leadership used its lobby in the United States to put such pressure on President Truman that he would agree to recognize the State of Israel after it was proclaimed. Joseph Stalin of the Soviet Union also promised the Kabbalistic leadership to recognize the new state as soon as it was proclaimed.

Aircraft and other military hardware had been purchased and stockpiled in Europe to be shipped as soon as Israel became a political state. On May 14, 1948, the Jewish leadership in Israel proclaimed the State of Israel and war immediately broke out as the armies of Egypt, Jordan and Saudi Arabia invaded Palestine.

Ariel Sharon was given the assignment of terrorizing the Palestinian population and his military units moved from village to village to slaughter all the men, women and children. The corpses were dumped into the water wells and buildings were set on fire. Fear gripped the Palestinian people within days and they fled to Lebanon, Jordan and Egypt

by the millions. This is how the Palestinian refugee problem started. The governments of Egypt, Jordan and Lebanon did not want to let these people settle down. They wanted to apply pressure on Israel by not allowing them to settle down and this is still true some 67 years (three generations) later.

In the meantime Russian and American military units showed up with a massive amount of war material that had been stockpiled in Europe and Russia. With superior weapons and training, the Israeli army with its hardened fighters from the Hagana and the Stern Gang were able to defeat the Arab armies and drive them out from Palestine.

The State of Israel was born through deception and brute force.

THE TRANSFER AGREEMENT

There were rumors circulating after World War 2 that the World Zionist Federation had co-operated with Hitler and his Nazi régime to bring Jews to Palestine.

The World Zionist Federation had not been able to recruit Jews from Germany and other European nations to settle in Palestine, British Jews had no desire to move to Palestine and the same held true for American Jews. Most of the Jews settling in Palestine from World War 1 until 1939 were poor uneducated Jews from Eastern Europe. They would make great soldiers, farmers and unskilled labor, but the Jewish leadership in Palestine needed engineers, teachers, doctors, and other educated Jews who lived in Germany and France.

In 1984 an American Jew named Edwin Black broke the silence and published a book called "The Transfer Agreement."⁷ It sent shockwaves throughout the Jewish community as they found out that their leadership had been co-operating with the Nazi government since 1933 to transfer German and French Jews against their will to Palestine.

The Nazi government promised to create such a hostile environment for Jews that they would leave Europe and immigrate to Palestine. A special bank was set up "The Palestine Trust Society for Advice for German Jews" and educated Jews were encouraged to give up their properties in Germany and turn it over to the German government. In return they would receive a certain sum of cash that could only be redeemed in Palestine. If they did not comply, they would have to endure harsh conditions and eventual transfer to labor camps.

The World Zionist Federation were well aware of the labor/death camps and still agreed to collaborate with the Nazis in order to get skilled people to move to Palestine. Most Christians don't even know this took place and a lot of Jewish people living in the United States and England today simply do not care. Their attitude is one of life being good for them now, so why bring up the past?

Any reasonable person can deduce that the State of Israel created in 1948 through murder and deception was the work of Satan. God simply does not operate that way. He promised to restore the Kingdom of Israel another way. **Ezekiel 37:21-28**

Remember, it's not so important how you begin your life after salvation, but how you finish it!
